Introduction: Bangladesh Internet Governance Forum (BIGF) is a multi-stakeholder governance group for policy dialogue on issues of Internet governance. It brings together all stakeholders in the Internet governance debate, whether they represent governments, the private sector, or civil society, including the technical and academic community, on an equal basis and through an open and inclusive process. The establishment of the BIGF was formally established and announced by the United Nations Secretary-General in July 2006.

In three days (29, 30 & 31 December) 16th Bangladesh Internet Governance Forum 2021 successfully concluded in a hybrid format with 46 speakers and 210 participants in 9 sessions.

Panel Session: 1

The three-day-long 16th Annual Bangladesh Internet Governance Forum (BIGF) was started on 29th December with the participation of stakeholders in the internet world. The inaugural session was started at a hotel in Dhaka. Mr. Mustafa Jabbar, Hon'ble Minister, Post and Telecommunications Division, Ministry of Posts, Telecommunications and Information Technology, Government of the People's Republic of Bangladesh was present as the Chief Guest. Mr. Hasanul Haq Inu, MP, Chairperson, Bangladesh Internet Governance Forum & Chairman, Parliamentary Standing Committee for Ministry of Information and Broadcasting chaired the session.

Bangladesh Internet Governance Forum (BIGF) works in conjunction with the United Nations Internet Governance Forum (UNIGF). It is a multi-stakeholder platform to engage in Internet governance-related issues. The Theme of the

inaugural session was Internet United: Access to Meaningful Connectivity and Social Inclusion.

Mohammad Abdul Haque Anu, Secretary-General, Bangladesh Internet Governance Forum briefed about the background of BIGF and highlighted some of the interventions of BIGF in the previous years. BIGF brings together all stakeholders especially youths in the Internet governance issues, digital divide and discrimination, connectivity for the rural youths whether they represent governments, the private sector or civil society, including the technical and academic community, on an equal basis and through an open and inclusive sustainable and trusted internet process.

Dr. Md. Rafiqul Matin, Managing Director, Bangladesh Telecommunications Company Ltd. mentioned we are working to establish an inclusive atmosphere in the fields of Science, Engineering and Management for telecommunications and ICT in Bangladesh to gear up government initiatives especially digital Bangladesh for an inclusive society.

Mr. Md. Nazrul Islam, Head of operations, Carnival Internet pointed out We are enabling a superior digital lifestyle by the touch of a great broadband internet service in the digital era digital age nationwide in which every moment and experience is filled with joy of celebration.

Engr. Pronab Kumar Saha, Deputy Project Director, Info-Sarker Phase-III Project, BCC, ICT Division highlighted that the Government with the vision of providing access to the Internet to rural areas has adopted two different packages to connect 1307 and 1293 unions under internet connectivity under the Info Sarkar-Phase 3 project. It will also cater for the development of network infrastructure & backbone network to all the districts & at the 488-Upazila level.

Mr. Rased Mehedi, President, Telecom Reporters' Network Bangladesh & Special Correspondent, The Daily Samakal said the opportunity for all to be meaningfully connected to the Internet, including unserved and underserved communities and those prevented by their gender, digital literacy, or affordability issues from being able to access the internet and its opportunities

Engr. Md. Safaet Hossain, Additional Director, IQAC & Head, Department of Computer Science & Engineering, City University mentioned digital literacy and affordable and inclusive connectivity are very essential in the era of the fourth industrial revolution.

Mr. Fakhruddin Ahmed, Country General Manager (Bangladesh) Cisco Technology Bangladesh Ltd. said Cisco is working as the worldwide leader in networking that transforms how people connect, communicate and collaborate for coping with the digital world.

Mr. AHM. Bazlur Rahman, Chief Executive Officer, Bangladesh NGOs Network for Radio and Communication (BNNRC) & Policy Research Fellow briefed about 16th UN IGF & UN Secretary General's Road Map for Digital Cooperation. Digital technology is shaping history. But there is also the sense that it is running away with us. Our ability to work together across disciplines and actors, across nations and political divides. We have a collective responsibility to give direction to these technologies so that we maximize benefits and curtail unintended consequences and malicious use.

Taimur Rahman, Chief Corporate & Regulatory Affairs Officer said Banglalink Country's Fastest 4G Sim Now offering higher data transfer rate with the fastest internet of 4G, now upload and transfer all your data faster than ever and promoting government initiatives of Digital Bangladesh.

Mr. Faruq Faisal, Regional Director, South Asia Article 19 said we should emphasize countering misinformation and disinformation from media. Digital literacy is very essential for promoting the issue of internet connectivity and reducing the digital divide.

Brig. Gen. Md. Nasim Parvez, NDC, Director General, Bangladesh Telecommunication Regulatory Commission (BTRC) in his speech mentioned some initiatives have been undertaken like fixing the maximum tariff for broadband internet connection. BTRC fixed the tariff after a series of meetings with operators of the International Internet Gateway, Nationwide Telecommunication Transmission Network, International Terrestrial Cable, and internet service

providers as part of the "One Country One Rate". He said the BTRC introduced the "One Country One Rate" tariff to attract foreign investment by boosting coordination among ISPs at the local level and protecting the interests of marginal broadband internet subscribers. Although the number of mobile internet users, in general, is high, broadband internet users of the country's total bandwidth.

Mr. Mustafa Jabbar, Hon'ble Minister, Post and Telecommunications Division, Ministry of Posts, Telecommunications and Information Technology, Government of the People's Republic of Bangladesh spoke in the session and emphasized removing the digital divide and gearing up all initiatives of the government undertaken for Leave No One Behind. The government has planned to bring all the civic amenities of the city to the villages. Under this initiative 'My Village, My City', many aims like road connectivity, internet connection, telecommunication, health center, drainage, and waste management have been set up. As promised in the election manifesto of the government, if the facilities of the city are expanded to the villages and rural youth and agri-entrepreneurs are brought under training, productive employment opportunities could help people in rural areas get basic government benefits equally.

Mr. Hasanul Haq Inu, MP, Chairperson, Bangladesh Internet Governance Forum & Chairman, Parliamentary Standing Committee for Ministry of Information and Broadcasting chaired the session. He said that we need a Digitally Sustainable Plan. The plan is to bring in a new system. To build an inclusive digital society and economy for all, the Internet must be cybersecurity provisions, to ensure human rights is an effective tool to ensure the rights of entrepreneurs in the digital market. Recognition of the Internet as a fundamental right; Implementation as a fundamental right demands time. Ensuring affordable high-speed internet connection on an urgent basis. Ms. Tamanna Mou, Fellow, Bangladesh School of Internet Governance moderated the session.

Panel Session: 9 | Implementation of the Recommendations of the High-level Panel on Digital Cooperation

The Closing Session was held on the Implementation of the Recommendations of the High-level Panel on Digital Cooperation. Mr. Mohammad Abdul Haque Anu, Secretary-General, Bangladesh Internet Governance Forum moderated the session and he highlighted the activities of BIGF carried out in the year 2021 in the meeting before starting the session. Mr. AHM. Bazlur Rahman-S21BR, Chief Executive Officer, Bangladesh NGOs Network for Radio and Communication discussed on UN Secretary General’s Road Map for Digital Cooperation, Mr. Rakibul Hassan, Former Military Staff Officer (Civil-Military Coordination), United Nations highlighted education, young people skill development and mention education is the frontier in the digital age, Mr. Musharraf Tansen, In-Country Representative, Bangladesh, MALALA FUND emphasized on education and reduce discrimination from the society between boys and girls in using a smartphone,

digital divide and education. Mr. Anir Chowdhury, Policy Advisor, Government of Bangladesh/UNDP mentioned digital equality for making an Innovative Bangladesh by 2041. He also highlighted the initiatives of the government and highlighted some statistics on TCV (Time, Cost and Visit), Mr. Hasanul Haq Inu, MP, Chairperson, Bangladesh Internet Governance Forum & Chairman, Parliamentary Standing Committee for Ministry of Information and Broadcasting emphasized equality, education, skill development and expected that BIGF and concerned department of the government will produce a Digitization Report on digital equality and also emphasized to develop and enact some policies and law in this connection. The necessary budget should be allocated in this regard and he said that humancentric Internet is the demand of the time.

Recommendations

- Affordable and reliable access and connectivity to devices must be provided—using a range of different approaches – equally to all sectors of the community, whether rural or urban, to all genders and sexual orientations, to persons with disabilities, indigenous peoples from underserved to unserved communities, marginalized communities
- Encourage and train youths to actively contribute at larger fora
- Strategies and best practices for protecting both systems and users.
- Ensure multi-stakeholder processes are inclusive and that governments engage in open and inclusive engagements with all stakeholders, including civil society and the technical community
- Organize World Summit on the Information Society (WSIS) Forum in Bangladesh every year
- Achieving universal connectivity by 2030/SDGs everyone should have safe and affordable access to the internet in line with rural Bangladesh.
- Ensuring the protection of human rights in the digital era human rights apply both online, offline, and social media
- People’s perception and understanding about Internet Governance and Bangladesh Internet Governance Forum
- Mobilize and promote youth forum for access to internet governance

Lesson learned

- Three-day events covered a large number of issues discussed in the BIGF
- Participants have realized the importance of Internet Governance and its application to improve the life of the community people.
- Bangladesh Internet Governance Forum 2021 identified and discuss trends, challenges and perceptions over time with specific groups of stakeholders about the global, regional, and national challenges. The Forum, therefore, was planned to help to identify and track the needs and expectations of the local stakeholders, Identify and track perceptions and attitudes of the local stakeholders, Provide feedback on specific global, regional, and national developments.

Conclusion

Bangladesh *Internet Governance Forum (BIGF)* is a multi-stakeholder governance group for policy dialogue on issues of Internet governance. It brings together all stakeholders in the Internet governance debate, whether they represent governments, the private sector, or civil society, including the technical and academic community, on an equal basis and through an open and inclusive process. The establishment of the BIGF was formally established and announced by the United Nations Secretary-General in July 2006. It was first convened in October–November 2006 and has held an annual meeting since then, since then Bangladesh Internet Governance Forum has been organizing the event in cooperation with all levels of stakeholders.
