1. The fourth virtual meeting of the Internet Governance Forum (IGF) Multistakeholder Advisory Group (MAG) in the IGF 2022 preparatory cycle was held on 11 April 2022 and was moderated by Mr. Paul Mitchell, MAG Chair.

Attached to this summary report are the meeting agenda (Annex I) and the list of participants (Annex I).

I. Call for IGF 2022 session proposals

2. The MAG Working Group on Workshop Process has finalised the <u>call for workshop proposals</u> and the <u>workshop proposal form</u> for IGF 2022, integrating comments from the previous MAG meeting. It was explained that the main adjustments relate to the criteria for workshop proposal evaluation; for instance, two previous criteria related to the hybrid nature and interactivity were merged into one criterion now called 'hybrid organisation strategy'. Some adjustments were also made to the submission form.

3. MAG members raised no further issues regarding the call and form for workshop proposals, which were approved.

4. Action items

a. The Secretariat to prepare the necessary webpages and forms related to the call for session proposals. The call is expected to be published by Friday, 15 April.

b. Once the call is published, MAG members to share the information among their networks and encourage submissions.

II. Updates from WG-Strategy

5. The MAG Working Group on IGF Strengthening and Strategy (WG-Strategy) provided several updates on its work:

- a. In order to further develop the WG's communication and coordination with the MAG, the group has decided that any action items coming out of its meetings would be shared directly with the MAG mailing list. This practice has already started being implemented, and the <u>summary report</u> of the group's most recent meeting has been shared with the MAG.
- b. The WG has been developing two documents a <u>plan of activities for 2022</u> and a <u>matrix of actionable items from the Secretariat's synthesis document</u>¹. The group's co-facilitators will finalise the documents, taking into account feedback from the Secretariat, and then share them with the MAG for feedback.
- c. It was acknowledged that concerns had been raised about the <u>contribution submitted by the WG</u> <u>to the IGF Expert Group Meeting</u>, given that the full MAG did not have a chance to comment on the document. As explained above, the WG is working on rectifying such issues for the future.

6. Action items
