



**IGF Leadership Panel
Meeting I
10 February 2023 | 13:00-14:30 UTC | Online**

The [Internet Governance Forum \(IGF\) Leadership Panel](#) held its first meeting of 2023 on 10 February online. The meeting discussed the Panel's organization of work for the cycle, including its proposed division into action-oriented working groups in line with its mandate, as well as preparations for its face-to-face meeting in Vienna, Austria, on 6-7 March. It also explored opportunities for members to advocate for the IGF in wider conferences and fora where they plan to participate.

Decisions, Action Items & Next Steps

- The Panel agreed upon four working groups based on proposals developed by Ms. Garza and Ms. Fuhr, as follows:
 - **Group A on Awareness-Raising and Outreach**, whose focus will be to map fora and processes within and outside the UN System where members can promote IGF, as well as organize possible outreach events
 - **Group B on Inputs to the IGF and Liaison with the MAG**, which will ensure close cooperation with the MAG throughout IGF programme planning, including for the selection of themes
 - **Group C on Fund Raising**, which will work together with the Secretariat, DESA and donor community to help increase contributions to the IGF Trust Fund; and
 - **Group D on Opportunities for Substantive Contributions and Guidance**, which, in taking advantage of the significant expertise and areas of interest on the panel, will develop common issues-based statements and recommendations, including a tentative framework on “The Internet We Want”
- Regarding the detailed objectives of each group, namely Group D and its emphasis on a shared narrative on “The Internet We Want”, it was agreed this would be continuously discussed and elaborated on by the group, with no enumerated principles yet fixed.
- The Panel appointed volunteer administrative chairs and assigned members to each group, as follows:

- As to the Panel's upcoming meeting in Vienna, a tentative press briefing and its details are still to be defined; it was said the Panel should use programme segments on “Common Messages” and its meeting with the MAG as opportunities to give input on the themes for IGF 2023.



- Looking ahead to the IGF in Kyoto, the Panel plans to meet a minimum of 3-5 times to maximize their in-person time together.
- Separate engagements of the members in meetings where they can advocate for the IGF are, as communicated: the UNESCO Internet for Trust conference (attended by Ms. Ressa and Mr. Sesan); World Mobile Congress (attended by Mr. Dowidar, Ms. Fuhr and Mr. Gill); ICANN Meeting (attended by Ms. Fuhr); Digital Rights and Inclusion Forum (organized and attended by Mr. Sesan); RightsCon (attended by Ms. Fuhr and Mr. Sesan); and a meeting of the UN Commission for Science and Technology for Development - CSTD (attended by Mr. Mitchell).
- Panel members are to share their participation in the above using the calendar and documents tool supplied by the Secretariat.
- The Secretariat will facilitate closer communication between the Panel and the World Economic Forum.
