#### Action points (Activities done in 2022):

1. An online survey was conducted using a questionnaire on the Survey Monkey platform for the 2022 annual flagship report. The questionnaire was circulated via the Facebook and Twitter handles of the IGF as well as other similar platforms such as LinkedIn. The survey was in the public domain from November 2022 till January 2023. People from a total of six continents, with 75 countries across the globe, responded to the survey. The DC-Jobs 2022 annual flagship report, released at the 18th IGF Kyoto, was based on the access and role of



the internet to bridge the divide between education and jobs by leveraging the tools of the internet. The report also highlighted key aspects associated with the internet and job creation in the digital age, and also touched upon the carbon footprint of our digital footprint. At the same time, the report highlighted some key action points that governments, organizations, and individuals may find helpful in planning their policies and formulating their programs.

- 3. In 2023, the team conducted 5 consultation sessions with stakeholders across sectors to gain valuable insights from experts for creating a Framework for Project CREATE.

A report with the Framework on Project CREATE (Collaborate to Realize Employment and Entrepreneurship Opportunities for All through a Technology Ecosystem) covering 9 sectors, namely, Retail; Agriculture; Tourism; Micro, Small, and Medium Enterprises (MSME); Infrastructure-Construction; GovTech Public Goods; Education; Health; and Environment, was also released by DC-Jobs at the 18th Internet Governance Forum, conducted in Kyoto, Japan in October 2023. A session on the topic, 'Internet For All to Livelihood For All' was conducted by Dr. Gupta.

The Dynamic Coalition on Internet & Jobs was also present at the annual forum in Japan, with the chairman, Dr. Rajendra Pratap Gupta, and co-ordinators of the Dynamic Coalition, Ms. Priya Shukla, and Mr. Saptarshi Gargari, present in-person in Kyoto in October 2023.
