Dynamic Coalition Coordination Group (DCCG)

Virtual Meeting #97 | 11 April 2025

Summary Report

The meeting discussed the first DC webinar and commended the organisers for hosting a highly successful event. It proposed a date for the next one, with a focus on more deliberate participation and collaboration with other initiatives within the IGF ecosystem. The DCCG also discussed potential future collaborations and the need for a more strategic approach to their work. The conversation ended with discussions on planning for collaborative sessions, the need for volunteers to lead various sections of a document, and the preparation of a webinar on the implementation of the Sao Paulo principles on multi-stakeholder participation.

I. Adoption of the draft agenda

The agenda of the DCCG meeting #97 was adopted as proposed and is available in Annex I. The call was co-moderated by the DCCG co-facilitators Jutta Croll and Markus Kummer. The list of participants is attached as Annex II.

II. DC Webinars: taking stock of the pilot webinar and preparation for the next webinars

The meeting noted that first webinar had over 100 participants. The IGF Secretariat proposed a date of 30 April for the next one. It was suggested that future webinars should be more deliberate in their participation and collaboration with other initiatives within the IGF ecosystem. The meeting also discussed the need for a more strategic approach to their work, with a focus on outcomes and evidence of their efforts in the IGF 2025 in Norway. They also discussed the potential for future collaborations with MAG members, BPFs, Policy networks, and other UN organizations. The DCCG discussed the upcoming webinars and their focus on internet policies. They also discussed integration of the DCs into the mainstream of the IGF family and the need to maintain the bottom-up nature of the DCs. There was a discussion about the limited physical spaces for sessions at the Norway IGF 2025, which could impact the number of sessions. It was highlighted to have a more focused program and the importance of having it ready in time.

III. DC Sessions at IGF 2025

The DCCG discussed planning for collaborative sessions and a main session at an upcoming IGF event. A Google [document](#) was shared with sections for four session ideas. It was suggested finding volunteers to take responsibility for each session, acting as coordinators. The group agreed on an 30 April deadline for preparing session narratives. Some participants are now beginning to add ideas to the shared document during the call. It was also suggested to form clusters for each collaborative session.

IV. DCs accountability

The Co-facilitator referred to a previous paper on collective efforts, which included interviews with DCs, and explored governance frameworks for the DCs. It was suggested that the DCs could develop a blueprint for DC governance frameworks as a source of inspiration. The next steps were to ask the DCs if they have anything in place that could be shared with the coordination group. The Co-facilitator proposed that the DCs share information on how they organize themselves, whether through written rules or unwritten ones. The group agreed to this proposal and decided to wait for feedback on individual governance frameworks at the next meeting. The conversation ended with an update from DC-G4P about the gamification tool, which was experiencing technical issues.

V. AOB

DCCG agreed to hold the next meeting on the 24 April to assess the progress of session preparation.

Next Steps

1. All DCs to share information on how they organize themselves and manage their cooperation, whether based on written or unwritten rules.
2. Avri to lead the preparation of the session proposals [document](#).
3. IGF Secretariat to organize a meeting on 24 April at 15:00 UTC focused on preparing session proposals.
4. IGF Secretariat to schedule the next DCCG meeting #98 for 8 May at 6:00 a.m. UTC.
5. DCs to continue working on filling out the [Google Doc for collaborative session ideas](#).
6. Gamification team to resolve technical issues and provide an update at the next meeting.
7. DCs to prepare for the upcoming webinar on 30 April at 15:30 UTC.
