BPF Cybersecurity 2019:

Analysis of 20 different international cybersecurity agreements and initiatives

Including the Paris Call for Trust and Security in Cyberspace, the norms packages adopted by the UN Group of Governmental Experts (UN GGE) and the Global Forum for Security in Cyberspace (GCSC)

The report identified best practices related to the implementation of different principles, norms, and policy approaches contained in these international agreements.
