Internet Governance Forum (IGF) Multistakeholder Advisory Group (MAG) Virtual Meeting II

27 January 2021 at 14:00 UTC

Summary Report

Action Items:

- MAG members to review all BPF proposals and share feedback through the MAG mailing list until 28 January.
- IGF Secretariat to share agenda for the First Open Consultations and MAG Meeting

- The second virtual meeting of the Internet Governance Forum Multistakeholder Advisory Group (MAG) of the IGF 2021 preparatory cycle took place on 27 January 2021 at 14:00 UTC. Ms. Anriette Esterhuysen moderated the meeting as the Chair of the 2020 MAG. Mr. Chengetai Masango represented the IGF Secretariat. The IGF 2021 Host Country was represented by Mr. Krzysztof Szubert from the Government of Poland.
- 2. The following are attached as annexes to this report: (1) Agenda; (2) List of participants; and (3) List of shared input documents. The meeting's transcript¹ is available on the IGF website.
- 3. The meeting's agenda focused on assessing proposals for the IGF 2021 Best Practice Forums (BPF) and MAG Working Groups (WG). The meeting began with welcoming remarks of the MAG Chair and Host Country Co-Chair, both confirming that the preparations go as planned. The Co-Chair noted that the Host Country runs continuous outreach activities with many public and private institutions.
- 4. From the IGF Secretariat, several updates were shared:
 - The <u>Call to Take Stock of IGF 2020 and Suggest Improvements for IGF 2021</u> closed on 20 January. Forty-nine (49) inputs were received, out of which 15% from Africa, 6% Asia Pacific, 4% Eastern Europe, 4% Latin America and the Caribbean (GRULAC) and 11% from WEOG.
 - The <u>Call for Thematic Inputs</u> remains open until 31 January. So far, a hundred and sixty-seven (167) inputs were received.
 - The First Open Consultations and MAG Meeting of the IGF 2021 planning cycle are tentatively planned to be hosted online from 22-26 February. Its draft agenda will be shared early next week with the MAG for consultations.

- The new intersessional activity, the <u>Policy Network on Environment and</u> <u>Digitalisation (PNE)</u> was launched. Two MAG members volunteered to be the co-facilitators. Everyone is invited to subscribe to an open mailing list².
- Participants were reminded of the updated <u>timeline</u>³ of the preparatory process.
- 5. The MAG Chair invited presentations of all received proposals for the MAG working groups (WG) and Best Practice Forums (BPF). It was explained that this meeting's purpose is to discuss the proposals, suggest improvements for the MAG's final decision on possible approval during the next meeting of the MAG.
- 6. For the MAG WGs, the Chair advised that duplication of work with the Secretariat's function is avoided and that each group has a specific use. A newly proposed <u>WG on Hybrid Meetings</u> briefly presented its proposal available at the IGF website⁴. The last year's WG on <u>IGF Strengthening and Strategy</u> informed about achievement made so far and announced to work on a new proposal for continuation in 2021. The proposal is expected to be submitted to the MAG in the next few days. Underlining that joining the MAG WGs is not mandatory, the MAG Chair encouraged members to join as these provide an opportunity to directly contribute to the IGF processes through innovative, sometimes multiyear, activities. The Chair asked for feedback on the WGs to be sent through the MAG mailing list.
- 7. Participants moved to discussing the Best Practice Forums (BPFs). The facilitator of the last year's BPF assessment exercise, the 'BPF on BPFs', provided a brief historic overview of the BPFs and pointed at a concrete set of <u>criteria</u>⁵ for new proposals the 'BPF on BPFs' developed last year. The particularly important aspect for successful BPFs would be engagement with other initiatives and organizations.
- 8. The MAG members that submitted BPF proposals briefly presented their main takeaways, as per the written submissions available at the IGF website⁶. After each proposal's presentation, participants shared their feedback, summarised in the table below. Some general comments were also shared:
 - BPFs to be 'tested' through the community, for the sake of understanding if there is support from other stakeholders for substantial support and cooperation;
 - For the sake of the BPFs better stakeholder engagement, such as with youth, parliamentarians and other groups, the proposals should have simpler, concise overviews outlining its mission, purpose and goals.
