

Internet Governance Forum (IGF) Dynamic Coalitions (DC) Virtual Coordination Meeting XXXVII, 26 June 2019 at 14:00 p.m. UTC

Summary Report

- 1. The thirty-seventh virtual meeting of the Dynamic Coalitions Coordination Group (DCCG) took place on 26 June 2019 at 14:00 p.m. UTC. The meeting was facilitated by Jutta Croll and Markus Kummer, with Eleonora Mazzucchi representing the IGF Secretariat. - 2. The agenda of the meeting (Annex I) focused on planning the DCs main session for the IGF 2019 annual meeting.
- 3. Jutta briefed coalitions on the recently held face-to-face meeting of the IGF Multistakeholder Advisory group (MAG) in Berlin. The updates were as follows:
 - a. The IGF 2019 Host Country will support the engagement of a number of parliamentarians from around the world and will develop specific programme for these participants to be hosted on the last day of the meeting;
 - b. The MAG is working on improving the reporting procedure after each session through a dedicated working group on reporting, open to everyone to join;
 - c. Day Zero will feature a session of high level representatives from various sectors;
 - d. DC individual sessions are included in the schedule with tentatively confirmed session durations at 90 minutes.
- 4. There was a broad agreement that the DCs main session should focus on the UN Sustainable Development Goals (SDGs). It was explained that each DC should communicate inputs identifying their work with a particular SDG and describe how their work reflects upon the SDGs. Inputs should be incorporated in a template form, developed by the DC co-facilitators and endorsed byDCs. session-call-for-inputs. The final deadline for inputs is: 26 July 2019.

- 5. From the DCs on the Sustainability of Journalism and News Media (DC-Sustainability) and Internet of Things (DC-IoT) it was confirmed their work already relates to a particular SDG and they will elaborate on this in their template submissions.
- 6. The co-facilitators underlined that the DCs main session should not duplicate its content and thematic focus with the MAG main session also related to the SDGs. The IGF Secretariat will inform on the proposal for the MAG main session on the SDGs as soon as announced.
- 7. The DC co-facilitator noted that Ms. Tatiana Tropina that moderated the DCs main session last year, has expressed interest to moderate this year's session as well.
- 8. The title of the session should be thought up by DCs, with a view to making it attractive for general participants and distinguishable from the other MAG main session on the SDGs.
- 9. DC-Sustainability made the suggestion that after the session, DCs develop a set of concrete messages, recommendations or outputs of that nature.
- 10. The group moved to discussing the visibility of DCs in general. The IGF Secretariat noted several queries had been received from DCs on improving their collective visibility. One of idea was to have DCs integrated in the IGF 2019 Newcomers Track and potentially develop some informational materials that would outline the DC work happening throughout the year. From the DC on the Internet Rights and Principles (IRPC), it was suggested that each DC could create a short video message presenting their work to be linked to the DC sessions in the IGF 2019 schedule. A number of participants agreed that in the past the DCs, the dedicated DCs booth at the IGF Village had not been effective. IRPC remarked that remarked that their own hosting of a booth at last year's IGF had worked well and that not having a booth could be a missed opportunity.
- 11. The meeting concluded with an agreement that the next DC virtual meeting should be hosted in July prior to the last MAG virtual meeting in the month.
- 12. The DC co-facilitators will share the DCs main session template form within next days through the DCs mailing list.
