- The representative of the OAS Cybersecurity Program briefly explained the methodology employed by the organization in the development of national cybersecurity strategies in the Americas.
- Mexico's CIO described the different stages for the development of the country's national cybersecurity strategy, stressing the importance of building trust and fostering multi-stakeholder engagement throughout the entire process.
- The representative of the US Department of State described the support provided by the US Department to improve cybersecurity capacity at the international level.
- The representative of the OECD explained the organization's work on cybersecurity and privacy matters, and the support provided to Mexico through the missions organized by the OAS Cybersecurity Program.

Please describe the Discussions that took place during the workshop session (3 paragraphs):

During the Open Forum it was stressed the importance of building trust and of fostering a multistakeholder engagement throughout the process for the development of a national cybersecurity strategy, as well as the importance of working to reach common grounds. Additionally, speakers pointed out the many topics that can be covered by national cybersecurity strategies and, as consequence, the need to define priority areas.

It was also discussed how cybersecurity must be viewed from a comprehensive perspective, focusing not only on fighting cybercrime, but also on country's social and economic prosperity. Moreover, Governments should take into account risk management considerations. That is, Government should address cybersecurity through a risk-based approach, in which risk is reduced to an acceptable level without undermining the full potential of the digital environment.

Finally, given that cybersecurity is a shared responsibility, it was stressed the importance of cooperation among different stakeholders. Trust should be the input and outcome of national cybersecurity strategies. To this end, it is essential to encourage meaningful and longstanding partnerships among stakeholders.

Please describe any Participant suggestions regarding the way forward/ potential next steps /key takeaways (3 paragraphs): Potential next steps would be to improve multi-stakeholder active participation in the implementation of the cybersecurity strategy; thereby, the importance of creating an institutional/governance model for cybersecurity with a functioning and effective multi-stakeholder approach.
