The general discussion revolved around the fact that developing countries coming from the three groups face problems to achieve sustainability and affordability of services and to ensure good quality in connectivity, due to commercial and geographical constraints.

The issue of the importance of an effective cooperation between the developing countries and the international organizations, financing institution, trough know – how and the transfer of technologies, was touch upon with clear understanding that more should be done, to empower developing countries in order for them to be able to fulfil their commitments towards the SDG's contained in the 2030 agenda.

Mme. Delgado spoke about the report on connectivity that the ITU is releasing and the impact that these indicators may have on the policymaking of LLDC's, LDC's and SID's as well as on the work of the ITU for the next years towards these nations.

Mme. Coffin also referred to the ISOC report on the matter and the work that the internet society is carrying out to benefit them as well as touch upon the realities faced by these states in their day by day business. She also explained the functioning of ISOC as to clarify the nature of their work and thus allow better and more effective contact.

Mr. Kurbalija explained the deep impact that the LLDC's, LDC's and SID's face, making emphasis on human resources from small island developing states and how the international community need to do better to ensure that all states receive the necessary opportunities to fully participate in the global agenda.

The Digital Minister from the Chinese Taipei, Madame Audrey Tang showed a path of success for their economy, based on the development of critical infrastructure, digital education and cooperation.

Delegates coming from SIDS mentioned that alliances and cooperative work will help the efforts of the more vulnerable and least developed states, and cost sharing could be a way of reducing the elevated costs of the services, that affect negatively quality and speed of internet and broadband services.
