2. Topic of the BPF Data and New Technologies

- -> the vast variety and high volume of data from connected devices, networks and applications contributes to solving complex problems and facing global challenges.
- -> concerns are growing on how the same data can be used and abused and risks to put users in a weak and powerless position.

The BPF will focus on how users' data is collected, analyzed and used, and best practices to ensure that the data is used to bring benefit and not to harm users.
