Internet Governance Forum (IGF) Multistakeholder Advisory Group (MAG) Virtual Meeting IX

26 May 2020 at 14:00 UTC

Summary Report

Major Outcomes:

- MAG members to comment on Draft Agenda for the Second Open Consultation and MAG Meetings by **5 June**.
- Deadline for evaluation of workshop proposals extended until 31 May.
- 1. The ninth virtual meeting of the Internet Governance Forum Multistakeholder Advisory Group (MAG) of the IGF 2020 preparatory cycle took place on 26 May 2020 at 14:00 UTC.
 - Ms. Anriette Esterhuysen moderated the meeting as the Chair of the 2020 MAG.
 - Mr. Chengetai Masango represented the IGF Secretariat.
 - The Host Country was represented by Ms. Anna Podgórska Buompane from the Polish Ministry of Digital Affairs.

- 2. The meeting focused on the experience of the MAG members in evaluating the workshop proposals, as well as preparations for the Second Open Consultation and MAG Meetings to be held 15-19 June 2020.
- 3. The Chair noted that it is possibility that IGF 2020 may need to be held virtually, and requested that MAG members consider ways that this could be achieved successfully, if needed.
- 4. The Chair reported that after consultations with the Internet Society, it had agreed to co-sponsor a paper analysing stakeholder participation at the IGF since its first event in 2006. She requested MAG members to think about topics for a series of short papers this year that would reflect on IGF's achievements and mandate.
- 5. Update on action items:



- Completed: order of fields on the workshop proposal and the workshop evaluation form put into the same order.
- Completed: updated next version of draft agenda for the Second Open Consultation and MAG Meetings, including putting times in UTC.
- 6. The IGF Secretariat gave an update on workshop evaluations: 17 MAG members have completed their allotted evaluations, 16 MAG members have partially completed their evaluations, and five MAG members have not yet started in the online system, but some may be doing the evaluations offline, then uploading them when they're completed, while others may be having connectivity problems during COVID-19 lockdowns. The deadline for MAG members to complete their evaluations was extended by two days, until **31 May**.
- 7. MAG members discussed the workshop evaluation process:
 - A MAG member suggested that in future, the Secretariat work with the host government to ensure that first time workshop proposals from stakeholders within the host country understand the process and requirements. The Chair suggested looking at this suggestion after the evaluations have been completed, but before the Second Open Consultations and MAG Meetings are held
 - In a quick online poll about the ease of the evaluation process, MAG members responded in the following way:
 - The process was smooth: 30%
 - The process was mostly smooth, but with difficulties at times: 58%
 - The process was challenging: 13%
 - The process was very challenging: 0 %
 - A MAG member suggested that proposers needed more help understanding the policy questions area of proposals.
 - It was also noted by a number of MAG members that diversity amongst proposed speakers was lacking, possibly due to COVID-19 making it harder for proposers to reach out to a wider range of people.
 - A MAG member suggested that given the COVID-19 pandemic, which wasn't a factor that was considered when the call for workshop proposals first went out, diversity in workshop speakers could be increased by encouraging workshop proposers to take advantage of virtual participation – this would enable speakers who wouldn't have even considered travelling to participate entirely online.
 - A MAG member raised the question of what to do with proposals that didn't work as workshops, but could be Day Zero or Open Forums.
 - A MAG member noted that perhaps an instructional video could be created in future to help workshop proposers better understand what is expected of a proposal.



- A MAG member also raised a question about how to evaluate workshops with a specific regional focus.
- The Working Group on Workshop Process (<u>WG-WSP</u>) reported on the progress it has been making on its draft document, General Guidance For Workshop Evaluation Process. The Working Group hopes to share it with the wider MAG shortly.
- A MAG member highlighted that there will be a lot of preparatory work for the workshop evaluation groups to do in the week before the Second Open Consultations and MAG Meetings, and urged members to make time for that.
- 8. Regarding the cost of Internet connectivity, and the high cost of connection in some countries, the IGF Secretariat reported that in response to queries by some MAG members, UN DESA was investigating how it could reimburse MAG members from developing countries for their Internet connections.
- 9. Regarding the Second Open Consultations and MAG meetings:
 - The Secretariat gave an update on the updated agenda for the meetings, to take place over five days, instead of the usual three days for a physical meeting, with sessions to take place in short bursts over different hours to cater for the many time zones people will be working in.
 - Due to the way that the meeting sessions have been organized to cater for as many participants as possible online, cost considerations mean there will be English and French interpretation available for the Open Consultations, but not for the MAG meeting. The Secretariat hopes to have presentation and briefing videos that are submitted before the meeting translated into French and English subtitles or for interpreted French and English audio versions to be made available.
 - Zoom supports breakout groups, so similar breakout sessions during the MAG meeting can take place in the virtual space.
- 10. There were brief updates from the Best Practice Forum on Local Content and the Dynamic Coalitions Coordination Group.
- 11. The IGF Secretariat encouraged any NRI that required assistance holding its event in a virtual space to contact the Secretariat for support.
- 12. In response to a query about the progress of the IGF website redevelopment, the IGF Secretariat noted that there were procedural rules to follow before the money could be received and for a public tender process to begin, but that ideas for improving the website could start to be collected now.
