## **Narrative Report**

#### About the South Sudan Internet Governance Forum:

The South Sudan IGF is an initiative that aims at engaging different stakeholders in South Sudan to discuss Internet governance issues within an annual IGF process, finalized with the South Sudan School of internet governance (SS-SIG) and the South Sudan Internet governance conference.

This initiative is intentional on maximizing the opportunity for:

- Open and inclusive dialogue and exchange of ideas on Internet governance (IG) related issues
- 2. The creation of opportunities to share best practices and experiences
- 3. Identification of emerging issues and bringing them to the attention of relevant bodies and the general public; and
- 4. ContributingtocapacitybuildingforInternetgovernance.

### South Sudan IGF 2022

The second edition of the SS-IGF was held on the 23<sup>rd</sup> September 2022 at **Palm Africa Hotel** in the capital city Juba, South Sudan. Bringing together around **200** participants from various stakeholders' groups under the theme "Towards a holistic approach to Internet Governance in South Sudan: Consumer Rights, Competition, and universal access."

The meeting was hosted under the umbrella of ICT 4 development Network which is the body hosting the secretariat for the South Sudan internet governance forum, ICT4DN also partnered with local initiatives of Koneta Hub and SafetyComm to organise the event and make it a success.

# **Preparatory Process:**

The 2022 IGF meeting is a long overdue of the 2020 IGF which has to be postponed multiple times due to the Covid-19 pandemic and other circumstances in the context of South Sudan which prevented the event to conducted virtually due to technical and connectivity concerns that would prevent many participants from attending the event, hence to due to inclusion concerns the organising committee had to postpone the event until it was feasible to be conducted.

Before the event was scheduled to take place in 2020, all the consultative meeting were held earlier and the theme was selected with consensus and contribution from the local internet community in alignment with the IGF guiding principles of bottom-up approach, transparency, and multi-stakeholderism, all was set until Covid hits and everything had to be put on held. In m July this year the SS-IGF secretariat held a consultative meeting to



re-organise the 2022 IGF with the same inputs were received in preparing for the 2020 preparatory processes
