II. Description of the organizing process

The organization of the IGF 2022 was under the coordination of ISICRI on behalf of the academic sector. Likewise, there was great support on the logistics side from Hiperderecho.

Similarly, two panels were performed per day. the different discussion panels were in charge of different organizations in relation and affinity to the topics to be dealt with each day.

A large participation was identified under the virtual format both in the free panels held during the morning and in the two expert discussion panels held in the afternoon of day 1 and 2.

This year's event took place normally except for the third day, which for reasons of political conjuncture could not take place and a general statement was sent canceling the activities for this day. A self-coup took place, the temporary closure of the Congress of the Republic was dictated to call for new elections and form an emergency government.

The IGF 2022 allowed important learning to be learned in terms of issues such as connectivity, data protection, information security, among others.

The IGF 2022 motivates us to continue promoting multi-stakeholder discussion on rights and the Internet, connectivity and the new challenges that emerging technologies pose. We understand that it is an arduous task and that continuing with the generation of spaces such as the IGF helps in this and generates institutionality.
