MAG Working Group on IGF Strengthening and Strategy

Online Meeting XXI 17 June 2021 at 1 p.m. UTC

Summary Report

The 22nd virtual meeting of the IGF MAG's Working Group (WG) on IGF Strengthening and Strategy (WG-Strategy) was held on 17 June 2021 at 1 p.m. UTC. The meeting was hosted and moderated by the Group's co-chair Concettina Cassa with a support of the co-chair Roman Chukov. The list of participants is annexed to this report. 1. Results Recommendations of the WG-Strategy during the OC and MAG meeting

<u>List of recommendations to the MAG for the OC and MAG meeting (June 23)</u> was presented as a short report of the WG's activities and discussed by the WG participants. Among recommendations there were: an idea of multi-year plan, mapping exercise between UN SG' Roadmap and the IGF activities, Issue Teams, IGF Priority Areas and Parliamentary track.

One of the ideas expressed during the discussion was to strengthen the IGF's relationships with other institutions through potential focal point in the IGF for working with other institutions.

2. MHLB discussion held on June 14

Multistakeholder High-level Body (MHLB) discussion was held on 14 June, where the IGF Secretariat and Office of the Envoy on Technology presented the suggestion/model on how to implement the MHLB. It served as an opportunity for final comments by stakeholders in this process.

Some participants of the WG strategy mentioned the controversial sides of the MHLB with regard to its relationship with the MAG and use of the IGF limited financial resources. Additional information on the MHLB process is required.

3. Comments to the Plan and Draft schedule for the IGF 2021 Preparatory Phase

Participants discussed the Plan and Draft schedule for the IGF 2021 Preparatory Phase. The role of NRIs was discussed as a potential resource to prepare good quality intro sessions for the preparatory phase. The idea of the preparatory phase is to facilitate closer integration with the intersessional work, so similar outreach has gone to the BPFs, DCs and PNs as well. Other suggestions were encouraged to be added to the document before the Open Consultations and MAG Meeting.

4. Mapping between the IGF activities and the UN SG's Roadmap for Digital Cooperation initiatives next steps

There is a working group that will be set to take care of the mapping exercise between the UN SG's Roadmap for Digital Cooperation and the IGF activities. 10 volunteers have been gathered to start this work during the next few weeks by providing a first template.

5. Update on behalf of the Office of the Envoy on Technology.

Jason Munyan gave an update to the WG Strategy members on the activities and developments regarding the UN SG's Roadmap on Digital Cooperation.

He informed that the Office of the Tech Envoy was involved in a virtual round table on digital inclusion, as well as different sessions at RightsCon. These are materials shared by Jason:
