Mandate:

DC DDHT creates educational and informational materials and makes these available to multi-stakeholders, working in the space of Data Driven Health Technologies. The unique attribute of this Dynamic Coalition, is that it is sector specific and focused on supporting quality eHealth Care outcomes, through a focus on quality data inputs, processing, risk management and reporting. The Dynamic Coalition (DC) cross-cuts technology sectors such as Artificial Intelligence, Internet of Things, Block Chain, Quantum Technology and subject matters such as Privacy, Health Finance, Ethics and so forth. There is no such current DC in operation.

These materials are expected to provide support for those individuals and entities, working collaboratively to achieve each of the seventeen United Nations Sustainable Development Goals through the use of eHealth tools, either directly, as for Goal # 3, or as a significant contributor, partner and influencer for all UN SDGs.
