



**Internet Governance Forum (IGF)  
Dynamic Coalitions (DC)  
Virtual Coordination Meeting XXXVIII, 30 July 2019 at 12:00 p.m. UTC**

**Summary Report**

1. The thirty-eighth virtual meeting of the Dynamic Coalitions Coordination Group (DCCG) took place on 30 July 2019 at 12:00 p.m. UTC. The meeting was facilitated by Jutta Croll and Markus Kummer, with Eleonora Mazzucchi representing the IGF Secretariat. 2. The agenda of the meeting (Annex I) focused on continuation of planning the DCs main session for the IGF 2019 annual meeting.
3. The co-facilitators informed participants the so far three (3) DC submissions were received. Concerns were raised regarding a large number of DCs that did not submit inputs, given that there are eighteen (18) active DCs. The co-facilitators have encouraged the Network to submit inputs as soon as possible and noted that submission of input is a condition for DCs participation in the main session.
4. The discussion developed around the deadline for final submission of the DC inputs. After several proposals, it was agreed that the deadline should be the 26<sup>th</sup> of August 2019. The facilitators reminded that the templates only require the DCs to identify the SDGs connected to their work. After receiving all inputs, the co-facilitators will take a one-week time to incorporate received inputs into the main session template.
5. DCs were reminded that the template is available on the IGF website as a webform: <https://www.intgovforum.org/multilingual/content/igf-2019-dynamic-coalitions-dc-main-session-call-for-inputs>
6. It was also said that the DCs could submit an additional one-page long input as a background document to their work and how they related to the SDGs, that would be helpful for the moderator to understand the essence of the individual DCs' work. The co-facilitators advised that these papers can be submitted by 15 September 2019.
7. It was reminded that the DCs should finalize the title of the session, that currently is in its working form: 'Dynamic Coalitions Joint Efforts to Achieve the SDGs', that should distinct the session from another main session also focused on the SDGs.

8. The IGF Secretariat has reminded that the MAG organizes an introductory session and all intersessional work will be represented there. The DC Network was advised to think on who could represent them in this session. Also, the DCs were encouraged to reflect on the possibility for hosting the traditional DCs Coordination Session on the last day of the meeting and the IGF Secretariat was asked to suggest possible time slots for this session.
9. For the DC on IoT and DC on Core Internet Values, the Secretariat was asked to explore options to have the two sessions schedule back to back within 180 minutes long slot in one meeting room, as their content and session logistics are interconnected.
10. Following a question from one of the Network's co-facilitators, the IGF Secretariat confirmed that the DCs will not host a joint booth at the IGF 2019 Village, due to lack of interest.
11. As the so far IGF Secretariat's support to the DC Network, Ms. Eleonora Mazzuchi announced to be taking a temporary leave, all participants shared their best wishes and thanked her for her excellent work in supporting the Network.
