

## IGF Multistakeholder Advisory Group (MAG) Virtual Meeting IV 25 April 2017

### Summary Report

1. The fourth Virtual MAG Meeting of the 2017 IGF preparatory cycle took place on 25 April. Ms. Lynn St. Amour moderated the meeting as Chair of the MAG and Mr. Chengetai Masango represented the IGF Secretariat. The agenda (**ANNEX I**) focused on the process for organizing IGF main sessions, and following up items from the [previous meeting](#), on new or pending MAG working groups and the final selection of BPFs for 2017.
2. At the start of the meeting the Secretariat gave a short update on the workshop and open forum proposals received to date. It was reported that some 25 submissions were made for workshops, and 4 for open forums, figures which are in keeping with previous years at this stage in the process as 90 percent of submissions are usually made during the last 48 hours from the deadline. It was said the calls for Day 0 events and IGF Village booths would be made shortly and follow synchronized deadlines.
3. An overview of the 2016 main sessions process was given by a MAG member who had facilitated the process. The [guidelines](#) had been thoroughly reviewed by the MAG last year and hence may not need significant revision. The guidelines outline both process and principles for how MAG members should organize main sessions, with emphasis on planning that is multistakeholder, open to inputs from stakeholder communities, and results in substantive topical sessions with diverse speakers. Some rules on what roles MAG members should play in their own and other main sessions, as well as best practices from organizers in previous years, are also provided. Several MAG members volunteered to participate in the effort to update the guidelines for 2017, in particular adding language to make online participation an explicit planning objective, adding details on the tagging process, and with advice from the Secretariat, devising an appropriate timeline. One MAG member suggested that the main sessions this year should take full advantage of the IGF's location in Geneva to engage stakeholders and experts from Governments and IGOs located there. The MAG Chair briefly gave a projection of the expected number of available main session slots, based on a preliminary 'main sessions grid' (**ANNEX II**), explaining there could be roughly between six and eight, but this is highly dependent upon the length of the sessions.
4. A short briefing was given on the proposal for a third potential phase of the '[Policy Options for Connecting and Enabling the Next Billion\(s\)](#)' (CENB III) initiative (**ANNEX III**). Phase III will focus on gathering global case studies on a limited number of the Sustainable Development Goals (SDGs) – SDGs 4 (Education), 5 (Gender Equality) and 9 (Industry, Innovation and Infrastructure) – impacted by Information Communication Technologies (ICTs). The proposal was supported by the MAG overall and it was decided CENB will continue in

2017, although it was noted that similarity with the work done by the International Telecommunication Union (ITU) to strengthen the WSIS-SDG nexus should be avoided in order not to duplicate efforts.

5. Elaborating on a fundraising memo shared with MAG members before the meeting, the Chair underlined the need for fundraising efforts to get underway as quickly as possible and suggested a decision on a more formal working group could be taken at a later date. Several members have already volunteered to contribute to this effort and will explore fundraising opportunities on an individual basis. Much support was expressed for the new working group on '[Multi-year Strategic Work Programme](#)' (ANNEX III), for which a draft outline had also been sent by the Chair. As part of the planning targets in the outline, it was said that MAG members' initial ideas on this should be presented at the next face-to-face meeting in June. The MAG Chair will co-facilitate this group with another MAG member, ideally from a different stakeholder community. Members were reassured that the group would coordinate closely with the new Working Group on IGF Improvements, and that these important issues would in any case involve the whole MAG. One member raised the question of non-MAG members potentially co-facilitating working groups, which had been discussed previously but without a final decision. The Chair asked that the question be put to the MAG mailing list for further discussion.

6. Presentations were given on each of the two pending Best Practice Forum (BPF) proposals for 2017 – on [International Cooperation](#) and [Local Content](#) (ANNEX III). Support has been extended to both of these in previous virtual meetings and on the mailing list. Given that the International Cooperation proposal builds on a workshop held at the IGF last year and that the issue warrants maximum visibility, it was ultimately decided that it would be best suited to a possible main session or Day 0 event. The BPF on Local Content, which members on the call continued to express support for, was approved for the 2017 cycle.

7. The meeting closed with agreement that the next call should discuss ideas for main sessions, as well as concrete remote participation strategies for IGF 2017, and Day 0 events. Members were informed the Chair and Secretariat were working on a calendar of future meetings and that this would be shared as soon as possible. The next virtual meeting is tentatively scheduled for **Tuesday, 9 May at 16.00 UTC.**
