**Guidelines for the granting of concessions:** These Guidelines include the terms and requirements for concessions of community and indigenous social use. Through these guidelines, on July 5, 2016, the Federal Telecommunications Institute authorized the first concession title to use frequency bands for indigenous social use to Telecomunicaciones Indígenas Comunitarias, Civil Society.

**Guidelines on Radio Spectrum Lease Authorization:** These Guidelines seek to establish the requirements, conditions and obligations by which the Institute may authorize the leasing or subleasing of frequency bands. These Guidelines shall seek the benefit of users, ensuring that the continuity of the provision of services is not affected and avoiding adverse effects on economic competition, such as concentration or cross-ownership of the public interest.
