The Youth IGF (www.youthigf.com) is a recognised initiative.

The Youth IGF is a global movement that operates as a multi-stakeholder platform. It allows the young (15-29 years old) to discuss and take a lead in issues related to Internet governance in the format of local, national or regional debates. These debates are organised by the young on a volunteer basis based on the methodology provided by the Youth IGF. The Youth IGF is based on the principles of the UN Internet Governance Forum (IGF) and full respect for them.

In 2016 more than 15 countries joined the movement and organised national or local debates. The message of the meetings is communicated to the leaders at different levels, among others during the UN IGF 2016.

The platform also serves as a hub to deliver capacity-building sessions to the young via the 'Train the Trainer' approach, and to raise their awareness on a number of Information Society issues.

The main objective of the initiative is to allow the voice of young people to be heard by Information Society leaders on issues related to internet governance and to help young people to take an active part in the decision-making processes.

The initiative also helps to reinforce active citizenship in young people and promote participation in the development of intercultural and intergenerational dialogues.

The concept of the Youth IGF gatherings is based on the idea of providing an inclusive opportunity for young people from both developed countries and developing nations, and particularly those who are facing social problems, to be able to express themselves and to convey their thoughts and concerns about the Internet to the community.

The Youth IGF movement was conceived during the First French Youth and Teenagers IGF, which took place in France in 2011 at the Council of Europe. It is an initiative developed by TaC-Together against Cybercrime International, French Youth and its partners, and supported by ICANN, Afnic and other international and national partners.

Short report

Youth IGF – EU Delegation IGF Open Forum

Over 150 participants attended the Open Forum Youth IGF – EU Delegation on the Day 1 of the United Nations Internet Governance Forum on December 6, 2016. The EU Delegation to the IGF was composed of 12 MEPs from different political groups of the European Parliament with Mrs. Pilar Del Castillo acting as head of the delegation. The European Commission was also present and its representation was headed by Mrs. Megan Richards.

During the Forum it was underlined that the multi-stakeholder model is of particular importance in the field of Internet Governance. Youth represents one of the layers of the multi-stakeholder model, maybe one of the most important. The opinion of young people on different aspects of Internet Governance such as security or the Internet of Things is important to all and of particular interest to the European Parliament. The young are advanced digital users in their daily lives and their vision and Internet habits are crucial. Their vision is the future and should be among the top priorities to be taken into account for the development of legal frameworks and in policy development work.

The arrival of the Internet in our lives over the last 20 years has brought many benefits but also a number of hazards. The young need to ensure that the benefits and advantages of the Internet will dominate in the future. This is their role, which is very important.

The Youth IGF - EU Delegation was underlined as being an important event in providing the opportunity to begin a reflection on how the young can participate more actively in dialogues with decision-makers. Youth IGF events can help to convey to decision-makers the opinion of the young who will determine how things will work in the future. In this sense, the Open Forum was described as unique.


Youth IGF events can be in terms of cooperation and development a reference point in a number of countries for other young people on how to establish their own ICT company. And this can add a lot of value and quality of life, but also in entrepreneurship.

In their messages to the decision-makers, the young underlined the need of the world's youth for capacity-building in different aspects related to the Internet Governance, among them safe and responsible use of the Internet, a culture of cybersecurity, privacy, entrepreneurship, Internet functionality, Internet ethics and on how to distinguish a trustworthy source online from a fake. They underlined the importance of the availability of training sessions in local languages and that these be accessible in different regions of the world. It was also emphasized that media literacy needs to be part of the school curricula.

The young argued that they need the help from leaders not only on how to set up a Youth IGF meeting, but how to make it sustainable. As quite often the young do not have enough influence and they need the different generations to help them, support from decision-makers is particularly important.

The youth of different regions also need to work together, since through collaboration and cooperation the voice of the young will only be stronger. The diversity of youth is really important and needs to be reflected in the sphere of Internet Governance.

It was agreed that Internet has to be a force for good, a force for peace, and has to be a force to bring us together. The Youth IGF could be a step that will help place the Internet in the vanguard of intercultural dialogue, which will help to build a safer and better, more peaceful world and which will allow us to live together in harmony.



MESSAGE

2. We need to know about....

- The topic of data protection and privacy for children
- · How news generates public opinion. Who has the power to judge whether a story is true or
- · People are not aware of the vulnerabilities of security protocols and the breaking of the most classic algorithms of cryptography ... people are exposed without education

- · Parental control should be stricter, and in such cases, demonstrate that there is a responsible figure behind that minor. A tutor or representative should be considered to provide a guarantee.
- · Generate categorisations of the information and articles cited, generating a label (such as that of transgenic products), a kind of alarm that warns that it does not have sufficient support from the sources. In Wikipedia this already exists, but not in digital media in general. Google could categorise this information in some way.
- · Launch a nationwide campaign to let people know about vulnerabilities and possible attacks and theft of information. This should be included in compulsory basic education for children, as well as adult refresher programs. It is important to build trust, but in the meantime through collaborative security approaches, people must know the risks they run when exposing their data on the Internet with vulnerable algorithms.
